Aventador coverage encompasses engine components including manifolds and sensors. The naturally aspirated V12 engine, while engineered for performance, may require specialized maintenance as vehicles accumulate mileage. Pre-owned Lamborghini vehicles receive coverage for age-related mechanical issues. Models such as the Murciélago and Gallardo may experience cooling system degradation, clutch wear, or suspension component failures over time.

The warranty plans include roadside assistance and claims processing through ASE-certified repair facilities. The company reports an average claims processing time of 48 hours. Coverage is accepted at dealerships and certified repair facilities nationwide.
